Affiliate Member: An affiliate member is a private aircraft owner and/or pilot. **Annual dues are \$50.00.**

Supporting Member: A supporting member is anyone retired from the business aviation industry or a full-time student enrolled in aviation studies and/or flight school. **Annual dues for retired are \$50.00. Annual dues for student are \$25.00.**
